# Notice of Traffic Management on Station Road North, Quainton

#### What are we doing?

Two-way temporary traffic lights need to be in place on a section of Station Road north to safely manage the traffic flow, and will continue until the eastern side of the new road realignment which leads onto Fiddlers Field Road, opens at the end of January 2026.

#### When will these works take place?

The temporary traffic lights will be in place between:

1 September 2025 to 31 January 2026.

These dates may be subject to change due to circumstances outside of our control, such as weather and ground conditions.

We will endeavour to complete these works in or around the set time frames. Please check the HS2 website regularly for any changes or updates.

Manage any environmental impacts, such as traffic and noise.


Respond promptly to any complaints and take appropriate action.
