What are we doing?

In September EKFB and National Highways will be carrying out embankment surveys alongside the A43 carriageway.

In order for these surveys to be completed safely, there will be temporary traffic management, a reduction to single lane traffic on the A43. To minimise disruption these will take place at off peak times.

When will these works take place?

There will be traffic management on the A43

The A43 will have traffic management for two days on Wednesday 17 and Thursday 18 September 2025 between 9:00am and 3:30pm.
