



UPDATE: Notice of overnight road closure on B4117 Gilson Road, Coleshill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To support ongoing preparations for the construction of the HS2 railway, traffic management will be introduced on Gilson Road to enable upcoming works on the M42 Water Orton Viaducts. These works are essential to safely construct the viaducts that will span across Gilson Road.

As part of the preparatory activity ahead of the long-term traffic management, an overnight road closure will be installed on Gilson Road

When the work will take place

UPDATE: Due to changes in the works program, the start date will be postponed a day. The overnight closure will be in place from 8pm on Tuesday 9 September and will remain in place until 6am on Wednesday 10 September 2025.

All vehicles will be directed to use the diversion in place. Pedestrian and cycle access will be maintained.
