High Speed Two (HS2) is the new high speed railway for Britain. EKFB is working in partnership with HS2 Ltd to build the new high speed railway in your area. You can sign up for regular updates in your local area at www.hs2innorthants.co.uk.

What are we doing?

Following the realignment of the highways near Boddington during Summer 2025, we are operating a link road to manage local traffic around the construction area.

In addition to this scheme and in partnership with the local highways authority, a one-way system will be in operation along Claydon Road, past Spella House. This will reduce traffic along this section of road, until such time as the required repairs can be undertaken.

Traffic will flow one-way northbound from Banbury Road to Warwick Road.

When will these works take place?

Monday 22 September 2025, 24-hours a day for approximately 12 months.

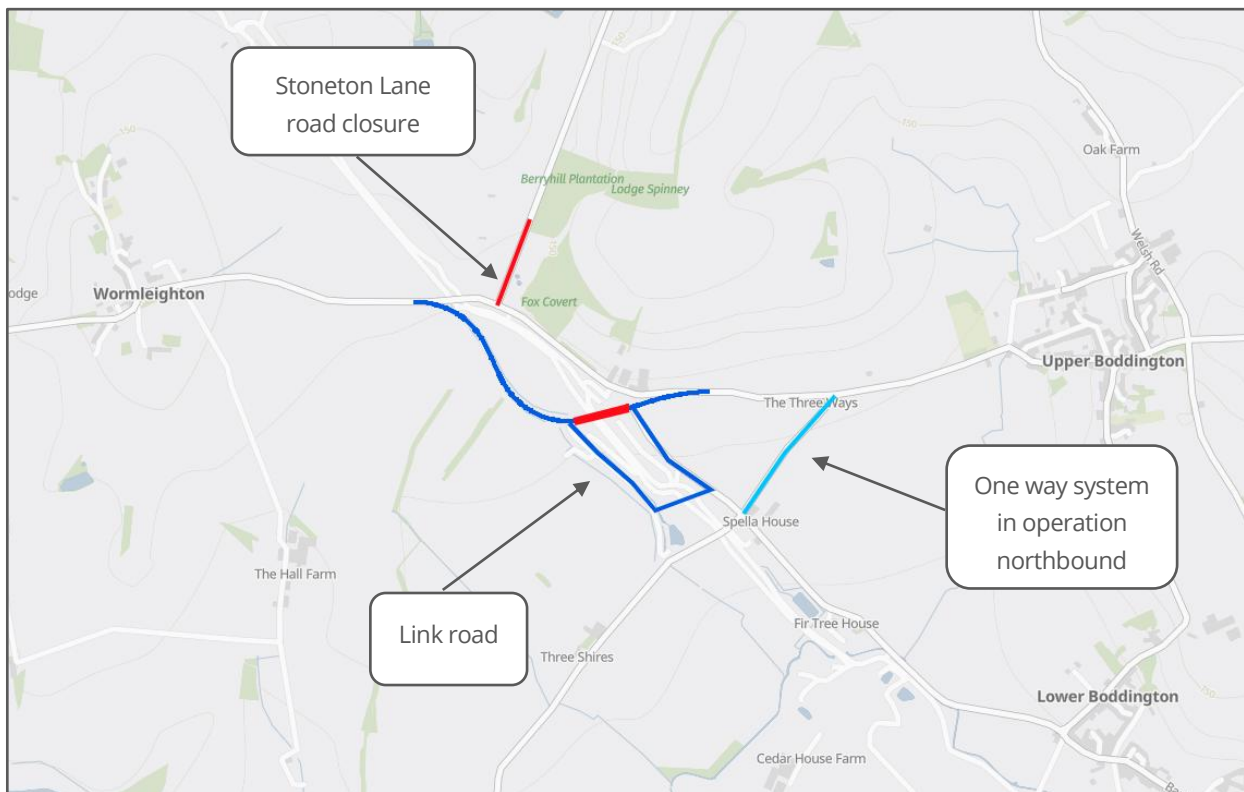
