



# Overnight closure of Lawley Middleway - A4540 Part of Birmingham's ring road

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

In August 2025, we successfully launched the Lawley Middleway Bridge, a key part of the new railway that will carry High Speed trains over Lawley Middleway and into Curzon Street Station in the centre of Birmingham.

We are now beginning the removal of the temporary substructure used to provide stability while the bridge deck was manoeuvred across the carriageway. The works will involve dismantling the substructure, sliding beams, and associated supports, with all loads progressively transferred onto the permanent bearings. This marks the completion of the launch phase and the bridge's transition to its permanent structural arrangement.

## When will this work take place

To ensure the safety of all road users, further closures of Lawley Middleway will be required. The road will be closed nightly from Garrison Circus to Curzon Circus between **10:00 PM** and **6:00 AM**, starting **3 October until 18 October** then a further closure from **24 October until 31 October**.

If you need to travel during these hours, please plan ahead. A clearly signed diversion route will be in place for all road users.

- Pedestrians and cyclists will be provided with a safe, signed diversion route.
- Access for emergency services will be maintained at all times, with safe escort through the closure in case of an emergency.
- Vehicle access to nearby critical businesses will also be maintained throughout the works.

Please refer to the map overleaf for details of the diversion route.

We appreciate your patience and cooperation as we carry out these essential works.

10:00 PM and 6:00 AM  
from **3 October** until **18 October**.

Then, 10:00 PM and 6:00 AM  
from **24 October** until **31 October**.

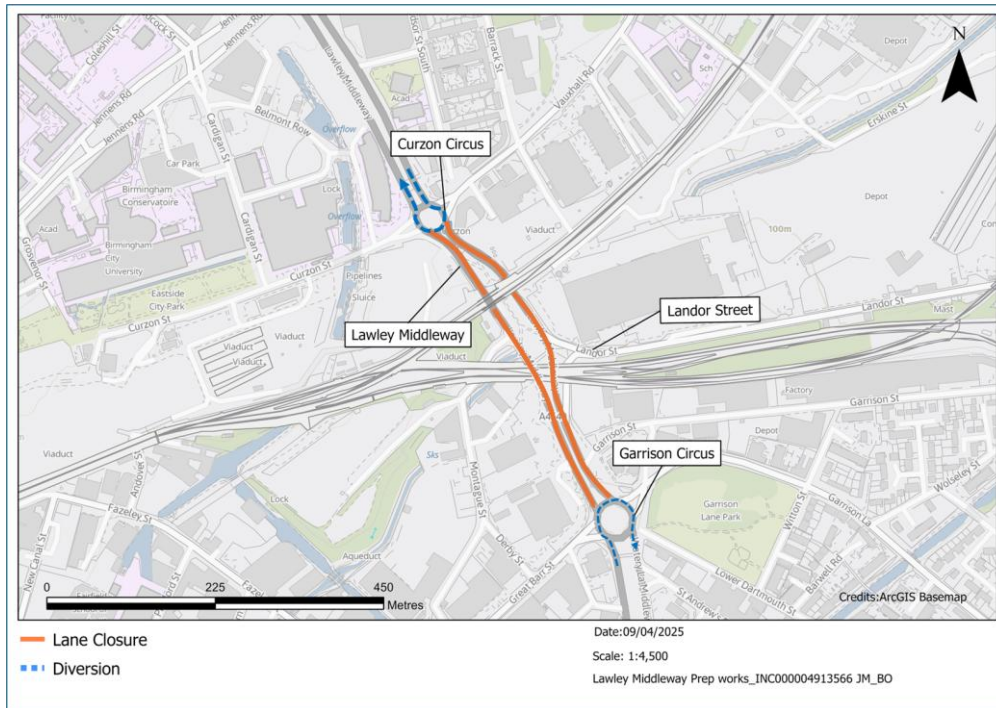

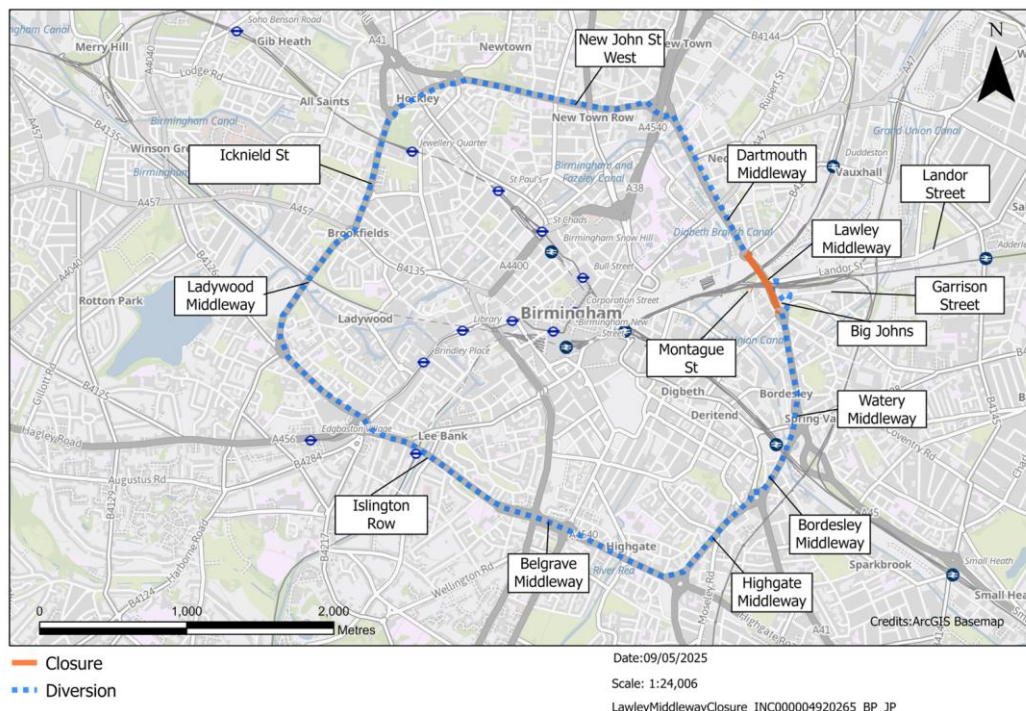

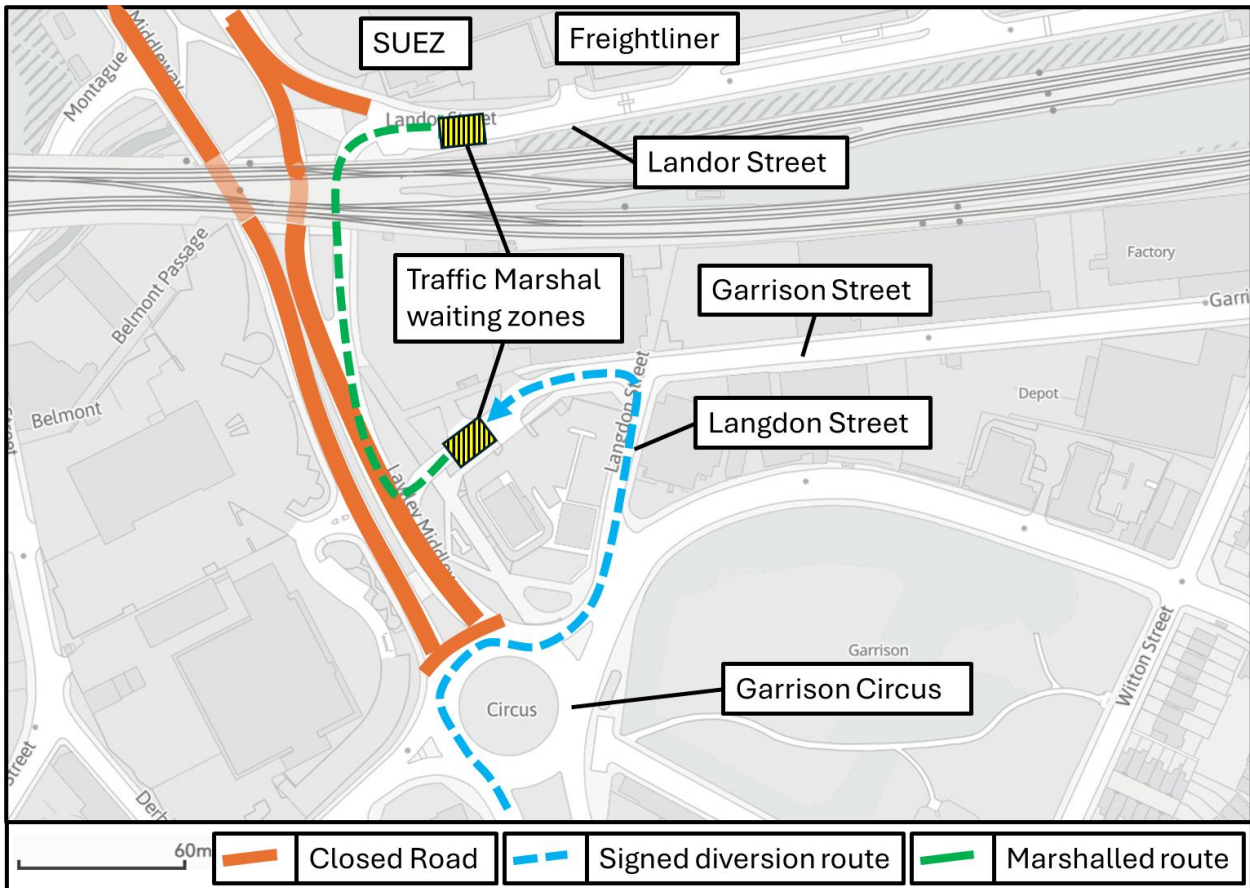

### Access arrangements for Landor Street

Between 10pm and 6am, vehicles will be diverted (fully signed) onto Langdon Street, where they'll be met by one of our traffic marshals. The marshal will then escort vehicles northbound using the southbound carriageway onto Landor Street.

We'll also have marshals assisting any vehicles leaving Landor Street, to ensure everyone remains safe throughout the closure
