High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

On the 22 and 23 September 2025, we will trim and clear low-level vegetation in the railway embankment near the Mandeville Road Vent Shaft site. This is to prepare the area for future works to install a high voltage power cable.

How this may affect you

We'll use handheld tools to carry out these works. You may hear some noise. We apologise for any disruption this work may cause.

The map below shows the two areas of the embankment where we will be working.
