Notice of lane closure to Jennens Road

High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Birmingham.

What we are doing

We are moving the current coach stop from Curzon Street to lennens Road.

To put this in place we need remove the old road markings on Jennens Road and repaint new ones. To carry out this work safely, we will close a lane overnight.

We have chosen Jennens Road for the new coach stop to enhance safety for all road users. This will remove coaches away from construction activity taking place on Curzon Street. It will also help maintain a smooth traffic flow throughout the work areas.

What to expect

Jennens Road will remain open, but we will put overnight lane closures in place.

Keep any disruption to a minimum.

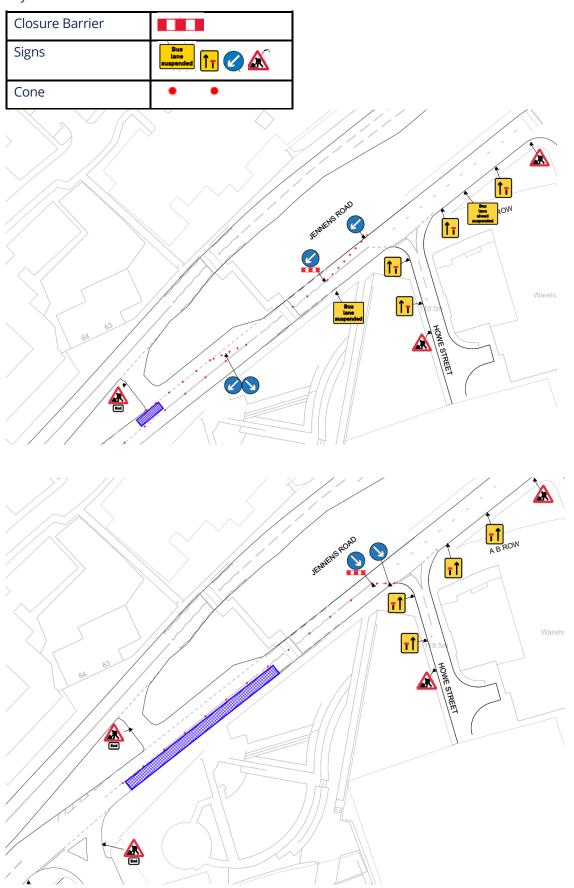
Keep one lane open on Jennens Road during the work.
