What are we doing?

From late September 2025 Station Road South will have traffic management in the form of 2-way lights to carry out de-vegetation works in advance of the eastern tie-in of the new alignment.

When will these works take place?

A section of Station Road South will have 2-way lights from Monday 29 September 2025 to Friday 3 October 2025.

These dates may be subject to change due to circumstances outside of our control, such as weather.

Respond promptly to any complaints and take appropriate action.


Notice of Traffic Management, Station Road South, Quainton
