
High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

Completion of retaining wall at HS2 main site

We are writing to inform you of upcoming construction activity in your area as part of our ongoing site enabling works.

From **mid-September**, we will complete the partially built retaining wall. This will stabilise the site and allow for a new internal vehicle route, supporting future construction phases. Further enabling works will follow. Following the completion of the retaining wall, we will continue with further enabling activities across the site to prepare for upcoming works.

We understand that construction activity can be disruptive to those living and working nearby. Due to the nature of these works, there may be **periods of increased noise**, particularly during excavation and concrete operations. While some disturbance is unavoidable, please be assured that we are making every effort to minimise noise and inconvenience, and we remain committed to keeping you informed throughout the works.



Duration of works

- Ongoing
- 8am to 6pm
 weekdays (excluding bank holidays)
- On occasions it may be necessary to work 8am to 6pm Saturday and Sundays as well as nighttime works
- Start-up and closedown activities up to one hour before and after working hours above
- Start-up and closedown activities up to one hour before and up to one hour after working hours above

- Aim to reduce noise and vibration as reasonably practicable
- Keep all sites safe and secure
