High Speed Two (HS2) is the new high speed railway for Britain.

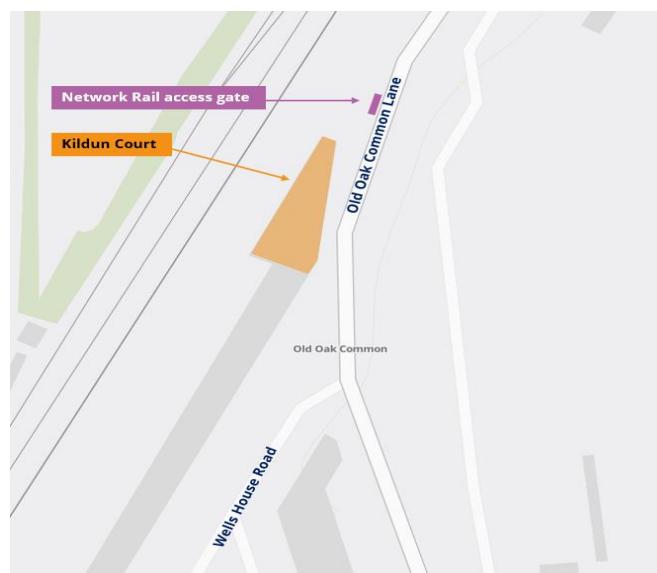
## What we are doing

We will be carrying out survey works at Kildun Court from **5 to 9 January 2026**. These works will include removal of internal doors, ongoing monitoring and maintenance within Kildun Court until 31 December 2026.

From March 2026 there will also be planned utilities works but we will confirm details of this closer to the time.

## How this may affect you

During this time, you may notice workers in or outside Kildun Court. There will be a traffic marshal to support with the access of deliveries into Kildun Court, but we will ensure pedestrian access is maintained. You may also see security staff regularly checking the building.
