



# Update: Kildun Court maintenance works, Old Oak Common

High Speed Two (HS2) is the new high speed railway for Britain.

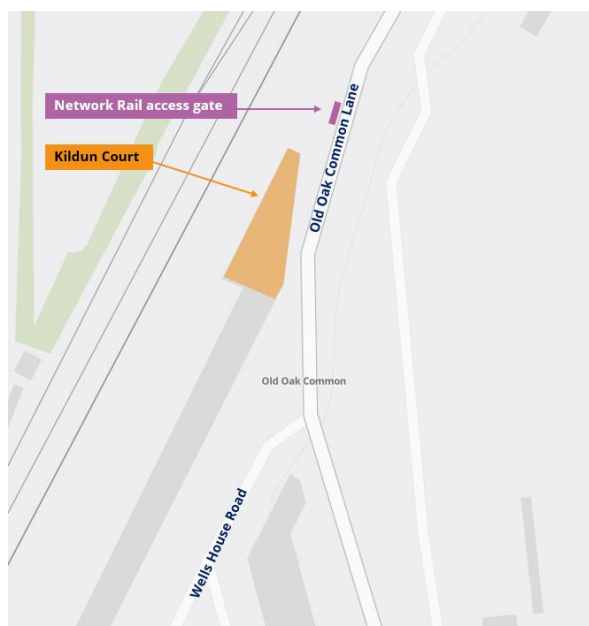
## What we are doing

On 17 September we shared with you that we would be carrying out essential works to secure Kildun Court from 1 to 8 October 2025, the internal works to support this has now been extended to **1 to 31 October**. Access to support with maintenance of Kildun Court will be required ongoing until December 2025.

## How this may affect you

During this time, you may notice workers in or outside Kildun Court. We will be installing additional security measures in and around the building. Barriers may need to be in place on the pavement, but we will ensure pedestrian access. You may also see increased security patrols to secure the building.

The area where the works will take place is shown on the map below.
