Responding to questions from our last meeting

Last quarterly meeting: 9 June 2025

You asked	Our response
Who will maintain the shared access road into the site when SCSJV are finished their works?	The access road will be shared by HS2 and Affinity Water, but the exact maintenance plan has not been agreed yet. There are currently no further details available about this.
Can the signage being left on Mandeville Road near the bus stop be moved?	The signage needs to remain in its current location from 7am to 7pm at a minimum. This is because the signage needs to be accessed and deployed quickly to facilitate vehicle movements to and from the site. However, we are looking at options for storing the signage nearer to site from 7pm to 7am.
Can you pick up the litter around the bottom of the signs?	Our traffic management operatives will do a daily litter pick around the signs.
Can the signage on Mandeville Road be turned around when not in use? (the signage is misleading as it says the left lane is closed when it is open)	Our Traffic and Highways team have reminded the traffic management operatives at the Mandeville Road site about turning the signage when not in use. If you have any concerns about signage on Mandeville Road, please contact the HS2 Helpdesk at the time so we can address this immediately with our Traffic and Highways team.
Can someone visit the site and local area to check the dust mitigations are working?	An air quality specialist visited the site and local area in late-June, following our quarterly meeting on 9 June. There were no issues identified with the dust control mitigations and monitoring taking place on site.
What is SCSJV is doing about the cracks in the Carr Road alleyway, as these are getting worse?	Our Mandeville Road site team are continuing to carry out daily inspections (including photos) of the cracks in Carr Road alleyway. The cracks have not changed since we started monitoring this last year. We will continue to monitor this.
We can hear staff shouting on site from our gardens, can you ask them to avoid shouting?	A reminder has been included in the start of shift briefings for all operatives on site about being mindful of our neighbours. If you have any concerns about operative behaviour, please contact the HS2 Helpdesk at the time so we can address this immediately with the site team.
How will site lighting be managed overnight during the 24/5 works?	The site lighting has been kept under review during the 24/5 works. If you have any concerns about site lighting, please contact the HS2 Helpdesk at the time so we can address this immediately with the site team.
How can residents access the data from the dust and noise monitors for the site?	SCSJV reports the data from our noise, vibration and air quality monitoring monthly for each local authority area. Mandeville Road site

Works planned on-site from September to December 2025*

24/5 works to remove slab at the bottom of the shaft

(works extended to 3 October 2025)

Extended working hours on
Saturdays to install
waterproofing and steel fixing
by the main shaft

(to late-September 2025)

Piling works in advance of future works to install a water chamber

(now planned 22 September to 24 October 2025)

<u>De-vegetation works in</u> <u>advance of high voltage</u> <u>power cable works</u>

(planned 22-23 September)

Works in railway embankment

(ongoing to mid November 2025)

Ongoing works to build headhouse base slab

(ongoing to mid-December 2025)

Installation of reinforced concrete walls for the headhouse

(ongoing to February 2026)

High voltage power cable works within the site

(planned from mid-to-late October – we'll write to you with more information)

Ongoing general site maintenance, security and deliveries will also continue.

Tunnel connection works

24/7 works below ground to connect the tunnel and main shaft from 3 October to 2 November 2025*

From **3 October to 2 November 2025**, we will work 24 hours a day, seven days a week below ground to connect the tunnel to the main shaft. This work needs to take place 24 hours a day for safety and engineering reasons.

You may notice ground-borne noise during this work. Residents who may be impacted have been contacted by letter and door knock in advance of the work.

Following this, we'll build an adit (horizontal passage) below ground and carry out works to connect the other tunnel and satellite shaft. The date for these works is yet to be confirmed. We'll write to you as soon as possible with more information.

Tunnel boring machine update

All four tunnel boring machines (TBMs) building the Northolt Tunnels between West Ruislip and Old Oak Common have now completed their journeys. In late July and late August, we lifted TBM Emily and TBM Anne's cutterhead, front and middle shield from Green Park Way Vent Shaft.

We are now building the emergency and maintenance walkways inside the tunnel and creating the connections between the tunnel and the South Ruislip and Mandeville Road ventilation shaft.

Summary of works planned from winter 2025/6 to winter 2026/7*

Internal works in the shafts

Operation of two cranes to move materials and construction equipment

Works to connect the shafts to the tunnels

Works to build the headhouse including concrete slabs and walls

Installation of a high voltage power cable – Mandeville Road / Badminton Close

Installation and operation of secondary vehicle access via Badminton Close

Installation of retaining walls in the railway embankment

Installation of utilities services in the existing site entrance and access road

Ground works and landscaping within the site boundary
