High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

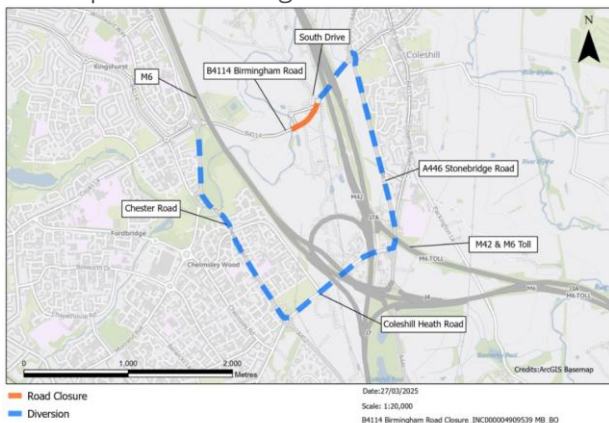
As part of the ongoing HS2 works, we will be carrying out essential construction activity on the new viaducts spanning the B4114 Birmingham Road. These works will include the installation of precast parapets which involves the concreting of parapet beams and completion of concrete finishing to the installed deck segments which span over the road. To facilitate this work, a full road closure will be in place on the B4114 Birmingham Road, from the junction of Manor Driver to the River Cole Bridge.

When the work will take place

To complete the works safely, we will operate a full road closure along the B4114 Birmingham Road. The works will take place from **6am on Monday 10 November to 7:30am on Monday 1 December 2025**. The road closure will be in place **24/7**. All vehicles will be directed to use the diversion in place. Pedestrian and cycle access will be maintained.
