High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

The work we will be doing

As part of the ongoing preparations for the HS2 railway construction, we will be carrying out essential utility works on Cadbury Drive, Castle vale. To facilitate these works, traffic management will be installed on Cadbury Drive.

When will the work take place

To carry this work out safely, we will install traffic management along Cadbury Drive. These works will take place from Monday 17 November to Friday 12 December 8am to 6pm. Access will be maintained for all vehicles and pedestrians.

Duration of works

Traffic Management on Cadbury Drive from Monday 17 November to Friday 12 December.

The traffic management will be a lane closure using stop and go signs. 8am to 6pm.
