High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

As part of the ongoing HS2 works, we will be carrying out essential utility preparation works near the three cottages on the B4114 Birmingham Road. This will include the removal of soil and rubble stockpiles, adjacent to the temporary tarmac car park.


To facilitate this work, we will temporarily block the access to the car park entrance whilst machinery and vehicles are using the area. A Traffic Marshall will be on site to assist with residents when accessing the car park.

When the work will take place

Works will take place from Monday 10 November to Friday 21 November 2025, from 8am to 5pm each working day. All vehicles using the car park will be marshalled through if required.
