What are we doing?

From October 2025, we will be undertaking intermittent clearing of the carriageway of the A413 Wendover bypass.

Due to road sweepers being in operation, there may be times where we are required to close the bypass (northbound only) for up to 1-hour as we undertake the sweeping. Road users going southbound will be able to continue using the Wendover bypass as normal.

To reduce impact on road users, these temporary road closures will be in operation during off-peak hours.

When will these works take place?

From 10 October 2025 – December 2027

These dates may be subject to change due to circumstances outside of our control but works will be completed in or around the set timeframes.

Intermittent closures of the Wendover bypass (northbound only) for up to 1 hour.

Temporary road closures on the Wendover bypass (northbound).

Various activities around the perimeter of the Wendover bypass.

Noise from road sweeper.

Manage any environmental impacts, such as traffic and noise.

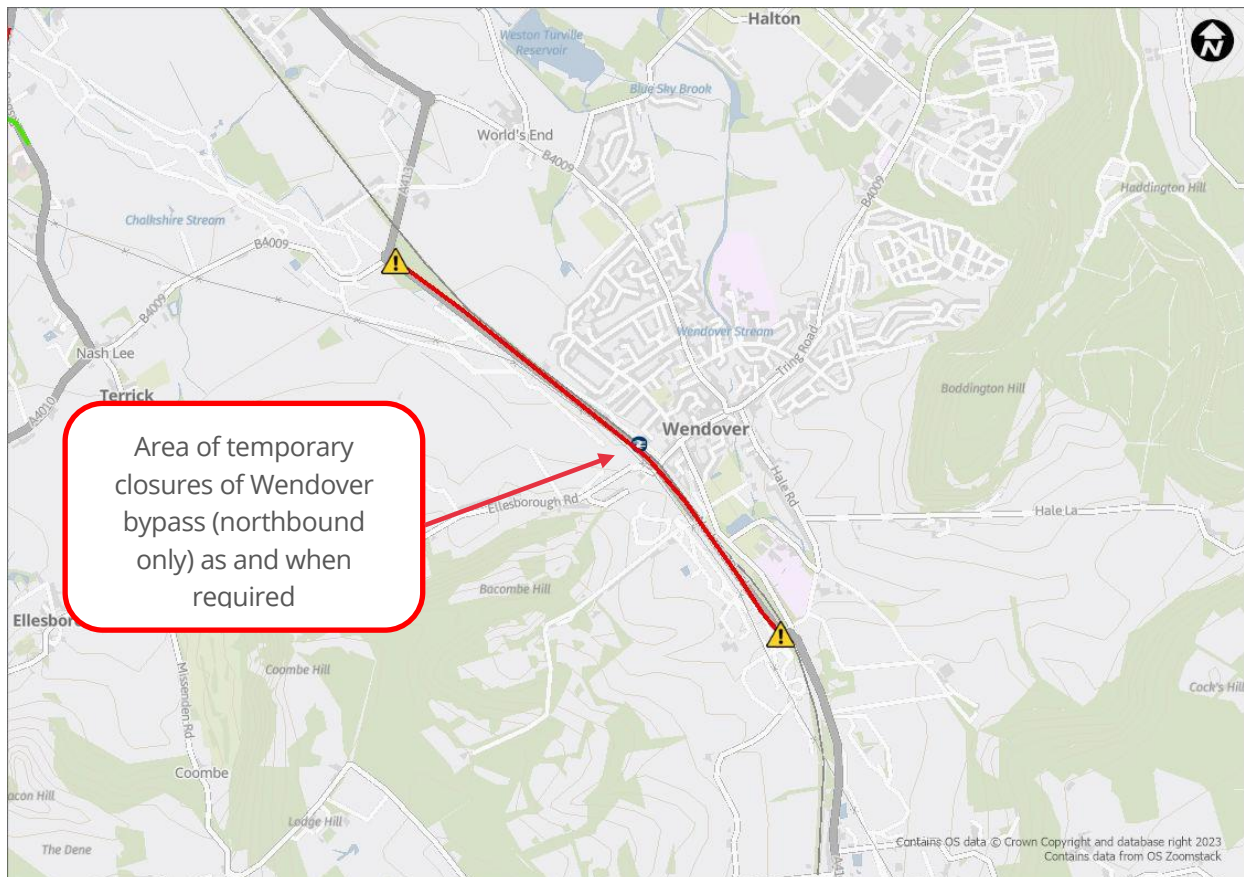
