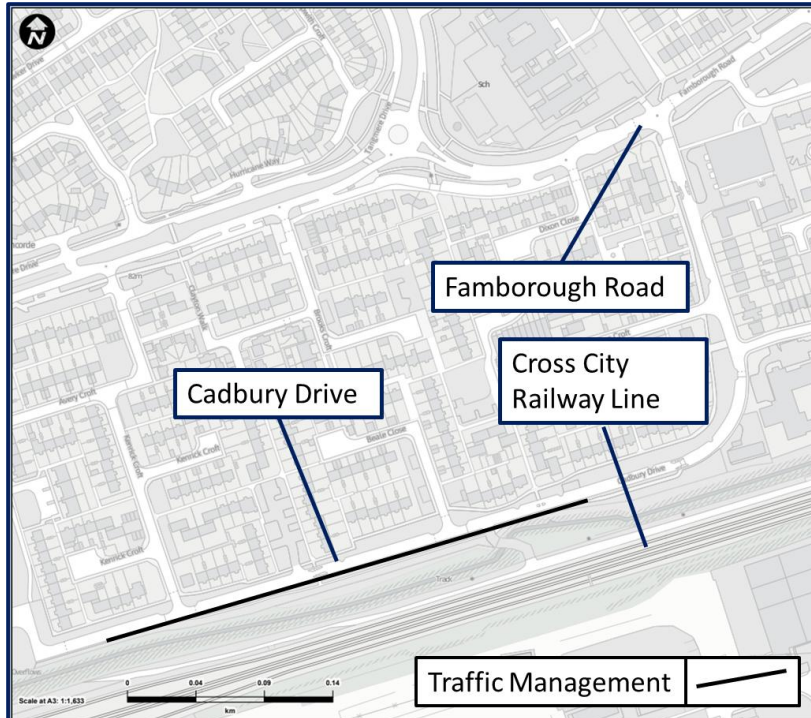
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

From 17 November to 12 December, we will be carrying out essential utility works on Cadbury Drive. To minimise disruption, we will be closing a short section of one lane only in the area where work is taking place on that day.

As the work progresses, the traffic management will move accordingly. This approach allows us to avoid the need for temporary traffic lights, helping to keep traffic flowing as smoothly as possible.
