High Speed Two (HS2) is the new high-speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

As we enter the final phasing of works for the permanent realignment of Crackley Lane in Spring 2026, we need to complete final utility connections and carriageway tie in works. We will be installing electricity and telephone services and connecting the new road. To do these works safely two road closures are required in early 2026.

We will need to close a section of Crackley Lane between Blind Lane, Cryfield Grange Road and South Hurst Farm.

When these works will take place

The first closure will be from **Monday 12 January 2026** to **Saturday 7 February 2026**. The second closure will be from **Monday 2 March to Saturday 28 March 2026**.

Once these works are complete the new road will open to the public.

What to expect

The closures will be in place 24 hours a day while the works are carried out. Access to properties will be maintained throughout the closure. There will be no access for pedestrians and cyclists.



- Talk to your local community engagement team about any queries you may have and community investment opportunities.


