# **HS2 Update**

Solihull | Autumn 2025

High Speed Two (HS2) is the new high speed railway for Britain. This update will provide you with key information and news on HS2 works in Solihull.

## M6 south viaduct

HS2 engineers have reopened the M6 motorway near Birmingham Airport ahead of schedule after sliding a 230-metre section of the new East Deck viaduct across the busy motorway.

The operation took place during a planned closure of both northbound and southbound carriageways, over the M6 Junction 4 slip road.

This second phase followed a successful first phase in June.

For the first time in the West Midlands, a 'fully restrained' sliding technique was used. This is where sections of the viaduct are built beside the motorway and pushed into place in stages to minimise disruption for motorists.

Plans to use this technique were developed in collaboration with National Highways to minimise disruption on the motorway and reduce the closure period.

The twin 320-metre viaducts will carry HS2 trains between London and Birmingham, with the West Deck, the third phase of the works, scheduled for installation next year.

We are currently planning this phase and will share details with you ahead of works commencing.

# **Progress of the viaducts**

Significant progress continues on the Balsall Common and River Blythe Viaducts, two key structures allowing the railway to cross waterways and local landscapes near Solihull.

The design of each structure aims to minimise the impact of HS2 on the landscape; local ecology, and views of the countryside; maintain existing public rights of way; enhance local habitats and respect the existing rural character of the landscape by using plant species found locally.

#### **River Blythe viaduct**

The River Blythe Viaduct is a 475-metre low-lying structure, that crosses the River Blythe and Meriden Road whilst anchoring itself to Diddington Lane Farm and Patrick Farm in Solihull. Construction is progressing well, with 14 of the 19 piers now complete, with the remainder to be finished by the end of the year. Over half of the beams have been installed and concrete has been poured on eight of the 20 deck sections. The Viaduct is planned for completion in Summer 2026.

#### **Balsall Common viaduct**

Balsall Common Viaduct is 425 metres long and approximately 10 metres above ground level as it crosses over Station Road, Heart of England Way Walk, Bayleys Brook and the associated floodplain. We have completed 12 of the 16 piers and over half of the bridge beams have been installed. Future phases of work include completing the bridge deck and installing the parapets. The viaduct is planned for completion in early 2027.

Once the viaduct structures are completed, we will landscape the area to carefully integrate the new infrastructure into the

existing environment. This will be followed by minor works including drainage improvements to manage water flow and prevent flooding, access enhancements to ensure safe and convenient routes for both construction and public use and fencing installation to secure the site. These final tasks will be completed prior to the full handover, expected in 2027.

## **Temporary road closures**

As we progress works on each of the viaducts, we will required temporary closures of Truggist Lane and Meriden Road in early 2026. We will share communications once the dates have been confirmed.

# Former A452 overbridge demolished

The successful demolition of the former A452 overbridge marks a key milestone in the transformation of the local road network for the future HS2 Interchange Station.

The overbridge, located near the NEC and Birmingham Airport, was removed over the weekend of 20–23 June 2025 by Solihull-based Armac Demolition, working on behalf of Balfour Beatty VINCI (BBV). The removal was carried out safely and efficiently over a weekend, following advance preparation works including trial holes and barrier installation.

The successful demolition has prepared the area for a new road layout that will improve access to the HS2 Interchange Station, a major future transport hub for the region.

Work has progressed on constructing a new roundabout that will connect the station to the A452 and A446. The removal of the former overbridge has cleared the way to complete this new junction.

# What is an overbridge?

An overbridge is a bridge that allows one route (typically a road or footpath) to pass over another often a railway or major road without interrupting the flow of traffic below. Overbridges can improve connectivity and safety by reducing congestion and removing level crossings or junctions.

Looking ahead, our teams will continue work on the new road infrastructure in the area, with further traffic management required to safely carry out the next phases of construction.

We will continue to keep you informed as work progresses through the remainder of 2025.

# Upcoming works

To ensure that the local road network is compatible with the new railway, we are remodelling and improving existing roads in addition to constructing bridges on motorway and trunk roads.

# Lavender Hall Lane overbridge and road realignment

Lavender Hall Lane overbridge will allow the railway line to pass under Lavender Hall Lane.

The 54-metre-long bridge will be connected to a new road realignment, which will raise the level of the existing road by ten metres. It will feature a new footpath to the north side, extending along the embankment, with wide verges either side of the sixmetre carriageway to allow for future walking and cycling facilities.

In addition to the overbridge, a new fivemetre-high culvert is being constructed to

the east, allowing Bayleys Brook to pass through the eastern embankment along its existing alignment. A range of utilities, including a medium-pressure gas main, currently running along Lavender Hall Lane, will also be diverted through the new bridge and embankment.

Due to land constraints and the scale and complexities of the construction sequence for this work we will require a long-term closure of Lavender Hall Lane. The HS2 Environmental Statement (ES) allows for a 12-month closure and through design and programme advances we aim to reduce this closure to approximately 9 months. The closure of Lavender Hall Lane is planned for early 2026 and we will share an updated communication once the dates have been confirmed.

# **A45 Coventry Road overbridge**

The new high-speed railway will pass under the A45 Coventry Road as it approaches the new Interchange Station being built in Solihull. This section of the A45 Coventry Road is located near Bickenhill, between Stonebridge roundabout and M42 Junction 6. The next phase will involve drainage works on the westbound carriageway.

To ensure we carry out these works safely, a section of the A45 Coventry Road

westbound carriageway will be temporarily closed from 9pm on Friday 31 October until 6am on Monday 3 November 2025. If required, contingency closures will take place from 9pm on Friday 5 December until 6am on Monday 8 December 2025. Access to local businesses will be maintained throughout. We will continue to keep you updated as the work progresses.

# Case study: Taiwo's story

In January 2025, Taiwo graduated from Warwick University with a degree in Humanitarian Engineering. Unable to find a role immediately, she received Universal Credit for several months and attempted to find work through her local Jobcentre. These months were challenging for Taiwo, and she felt demoralised by her inability to find an opportunity.

In March, she noticed that BBV/HS2 had organised a community drop-in event in Water Orton and decided to try her luck and see if a recruitment team would be present. At the event, she engaged with the SEE Team who were able to secure Taiwo a six-month paid placement as a Design Co-ordinator (beginning June 2025).

Taiwo's placement will end in September 2025 to enable her to join the HS2 Project Manager Graduate Scheme.

Meanwhile, Heart of England School in Balsall Common asked for help revitalising an outdoor space ahead of their students return.


BBV volunteers stepped in to clear overgrown vegetation and replace broken picnic tables, giving students a refreshed and welcoming space for the new term.

As part of this engagement our senior ecologist, Emma Hankinson, visited the centre to undertake a habitat and protected species survey within their grounds to aid with a planning application for a new kennel block. Emma loves dogs and has two of her own, and has previously owned a Belgian Malinois, a breed used by the police.

During the visit, it was mentioned that a female Belgian Malinois brood dog, 'Rana' required a

# **HS2** Reset
