



Notice of Park Street hoarding and security gate improvements

High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Birmingham.

What we are doing

We are increasing the height of the hoarding at the highway dead-end section of Park Street, adjacent to the Polish Millennium House and at the junction with Bordesley Street. This is to provide improved security by installing new security features including security fans and roller toppers along the length of the new hoarding.

This will ensure the protection and safety of Network Rail infrastructure and our construction site from trespassers.

On Saturday 8 November to Saturday 13th December, we will start the groundwork on the inside of the site.

On Saturday 8th November to Saturday 13th December, we will be repositioning the concrete blocks inside the site to stabilise the new hoarding.

On Saturday 8th November to Saturday 13th December, we will install the new hoarding roller toppers and new security gate.

Park Street and Bordesley Street will remain open during these works.

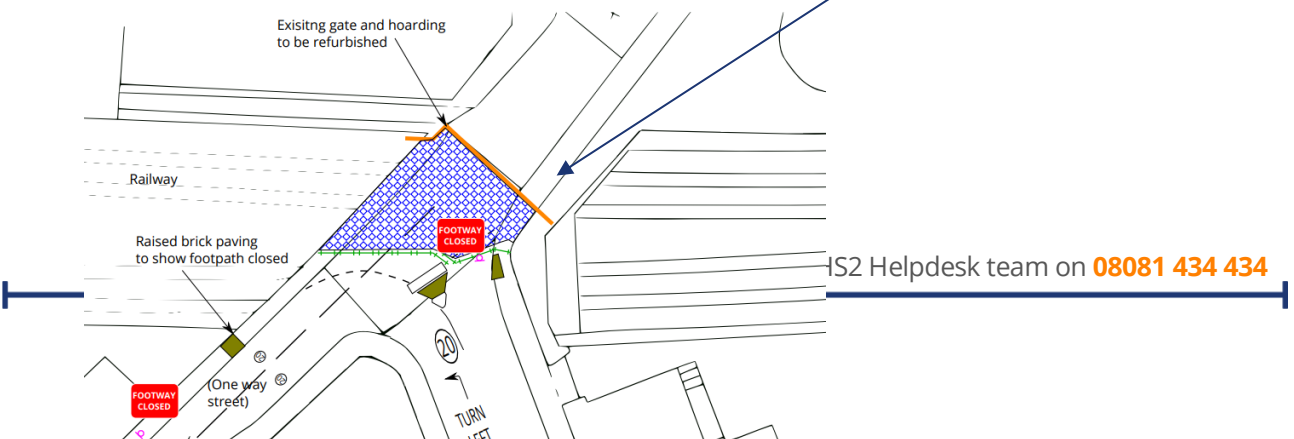
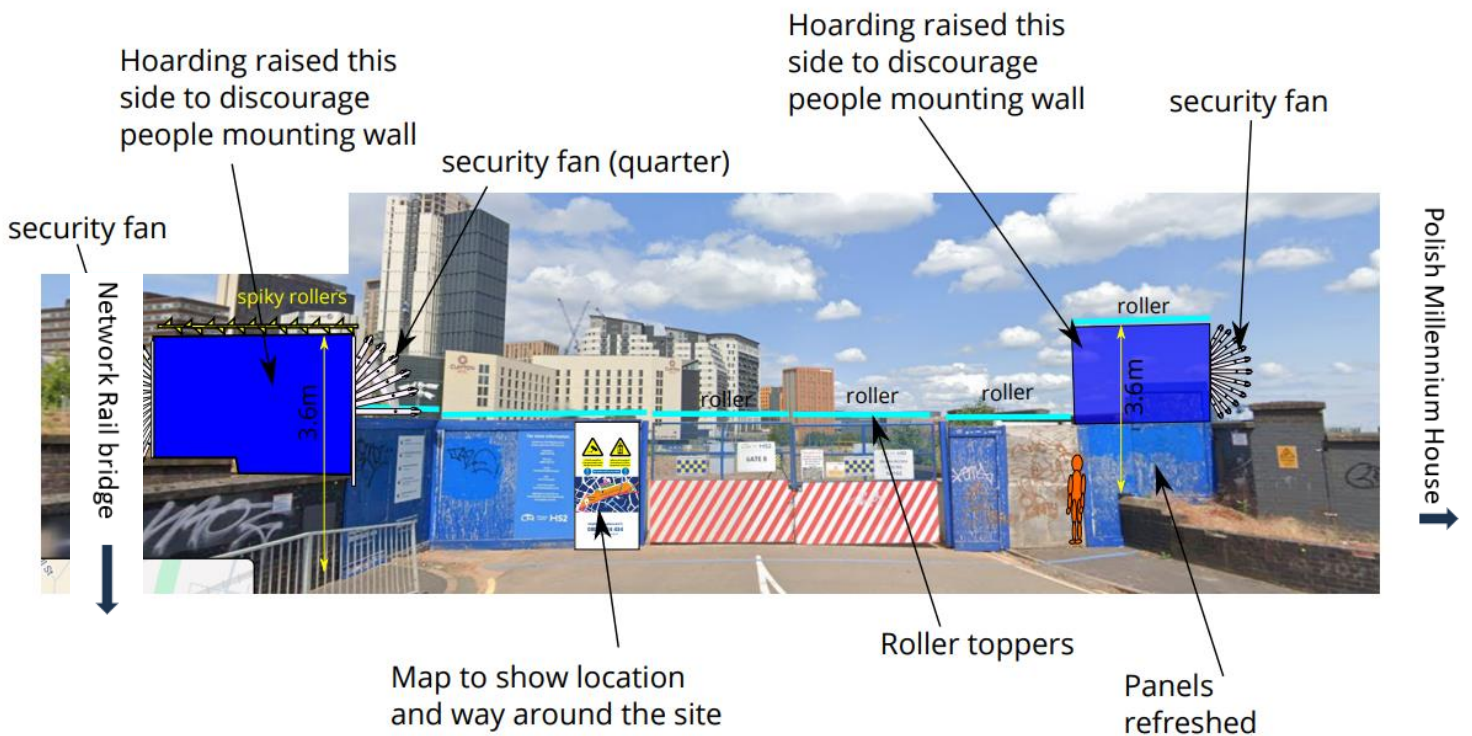
