Notice of footpath closures, AN6, AN39, AN42 and AY12, near Sulgrave

What are we doing?

As part of our continuing construction activities for the Greatworth green tunnel, we are continuing the closures of footpaths AN6, AN39, AN42 and AN12 which are adjacent to our work sites.

Affected footpaths have physical closure notices for pedestrian users.

Public Rights of Way (PRoW) closures are in place to allow us to safely use the land and to continue to build the new HS2 railway.

When will these works take place?

These footpaths will remain closed until the Greatworth green tunnel is completed and we can safely re-open these public rights of way. This is anticipated to be in winter 2027.

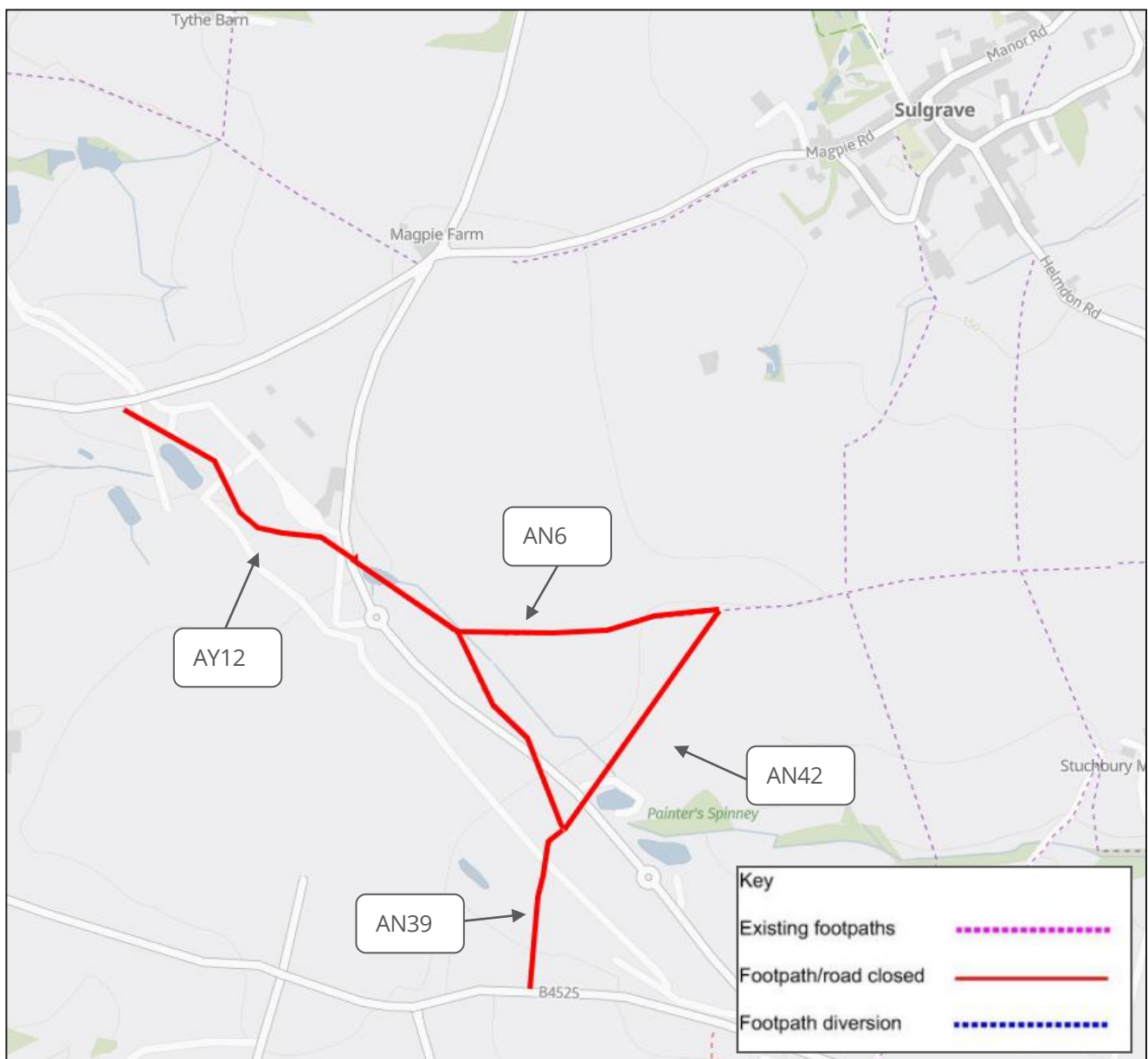
