High Speed Two (HS2) is the new high speed railway for Britain. You can sign up for regular updates in your local area at www.hs2inyourarea.co.uk.

What are we doing?

We will be closing Radstone Road, Radstone. During the closure we will be carrying out the permanent tie-in works to move traffic onto the new road alignment. The works we will be completing during this road closure will include drainage, earthworks and road surfacing.

Due to safety reasons and the narrow width of the road, these works will require a full road closure. We will reopen the road as soon as possible.

The road will be open for pedestrians and cyclists, however we ask cyclists to dismount when travelling through the works area.

When will these works take place?

A section of Radstone Road will be closed, with signed diversion in place, on the following dates:

- Monday 3 November to Sunday 14 December 2025

These works may be subject to change due to circumstances outside of our control. We will update communities in advance.

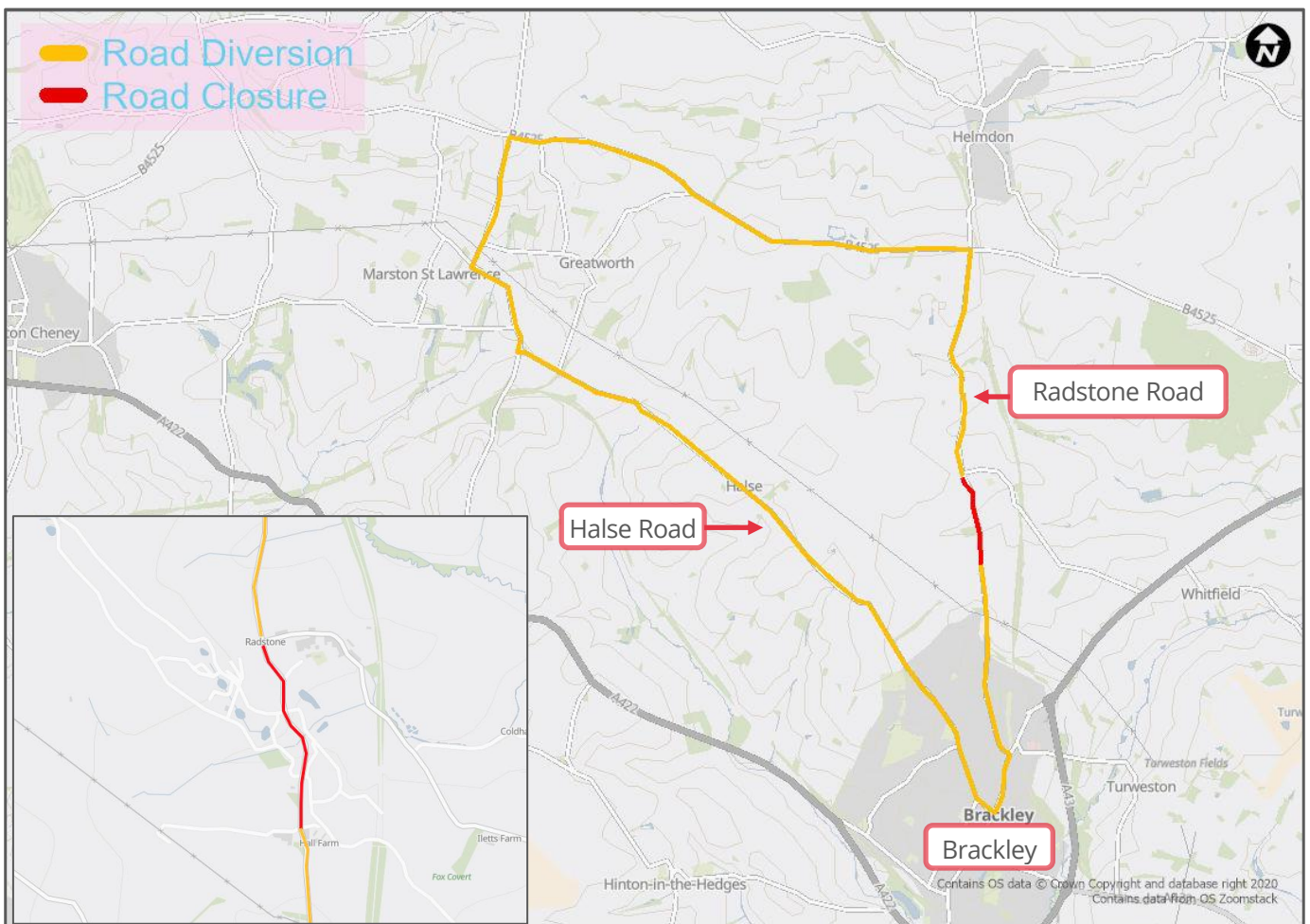
