High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

A new high-speed railway station is being built within Solihull, near the M42, A45 Coventry Road and A446 Stonebridge Road, close to the NEC, Birmingham Business Park and Birmingham Airport.

Our next phase of planned works involves cable pulling activities on the newly built roundabout over the trace on the A452 Chester Road, near Melbicks Garden Centre.

To ensure the safety of the public and our workforce, these works will take place during off-peak hours Monday to Friday between 9.30am and 3.30pm under lane closures.

Off-peak daytime lane closures:

- Each weekday between 9.30am and 3.30pm from Monday 10 November until Friday 28 November 2025

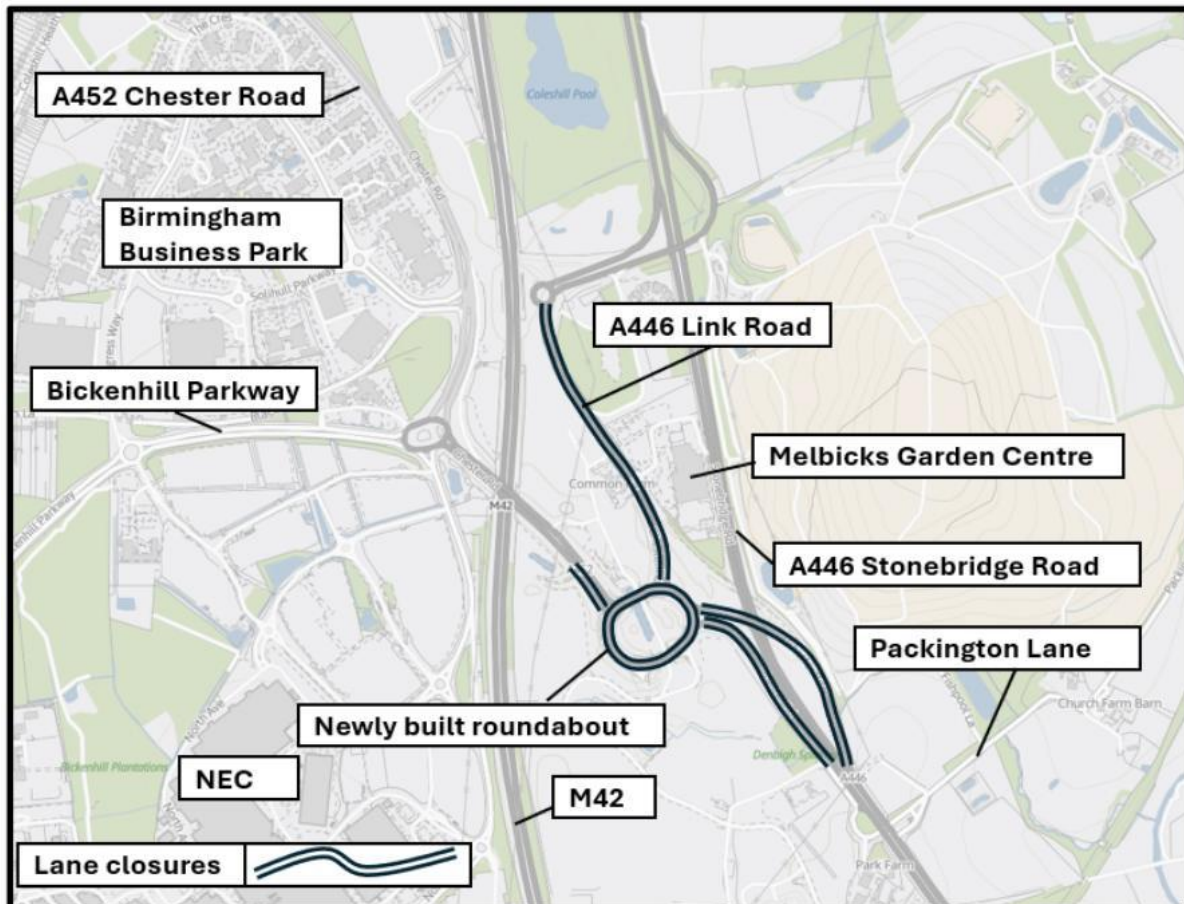

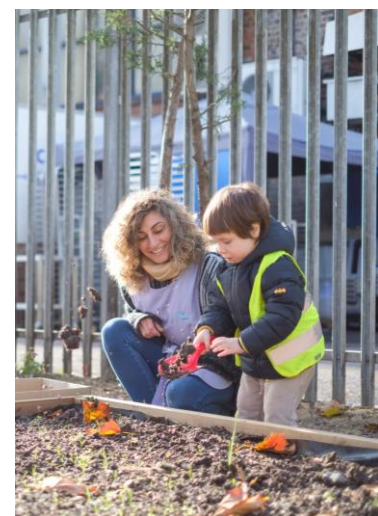
About our Community and Business Funds
