What are we doing?

From 15 October there will be 2-way, followed by 3-way temporary traffic lights in place on Portway Road, Twyford and the junction with the Twyford to Steeple Claydon Road. These will be in place to facilitate the excavation of trial holes, in advance of the long-term closure of the Twyford to Steeple Claydon road later in 2025. The traffic management will take place in three phases, as follows;

- 15 19 October 2-way lights
- 23 28 October 2-way lights
- 28 October 2 November 3-way lights.

When will these works take place?

The traffic management will be in place from Wednesday 15 October to Sunday 2 November 2025.

These dates may be subject to change due to circumstances outside of our control, such as weather.
