



# Updated Notice of traffic management on Hams Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## Traffic management on Hams Lane

We will be undertaking single lane closures on Hams Lane, Coleshill over a 5-week period, in two separate phases, to carry out utility works on the roadside verge.

During each phase of work, a series of single lane closures will be controlled with two-way traffic lights.

We were due to have a full four day closure in place but this is no longer required and will be replaced by a single lane closure.

## When will the work take place

These single lane and full closures will be implemented from **9.30am-4.30pm** each weekday over the following period:

- **Monday 20 October 2025 to Friday 14 November 2025** (two-way traffic lights) (not including weekends)
- **Monday 24 November 2025 to Friday 28 November 2025** (two-way traffic lights)
- **Monday 1 December 2025 to Friday 5 December 2025** (two-way traffic lights)

Please note that we have planned the single lane closures on Hams Lane, Coleshill to avoid peak traffic flow periods.

- Monday 20 October to Friday 14 November (two-way traffic lights)
- Monday 24 November 2025 to Friday 28 November 2025 (two-way traffic lights)
- Monday 1 December to Friday 5 December (two-way traffic lights) 9.30am-4.30pm each weekday during this period


