## What we are doing

From 5 December 2025, we will carry out sheet pile modification and removal at multiple locations within our site at West Ruislip Portal. Please refer to the map on the next page for the exact locations of these works.

Sheet piles are used to stabilise the ground and provide support for the structures above. Modification works involve cutting or burning the previously installed piles to reduce them to the required height. Removal involves vibrating the piles to pull them out of the ground.

These works will be noisy. To minimise impact to local residents, we will not start these works until after 9am.

## How this may affect you

You may notice periods of increased noise during these works. However, every effort is being taken to ensure these works are carried out in the least impactful way.

We would like to apologise in advance for any disruption this may cause.

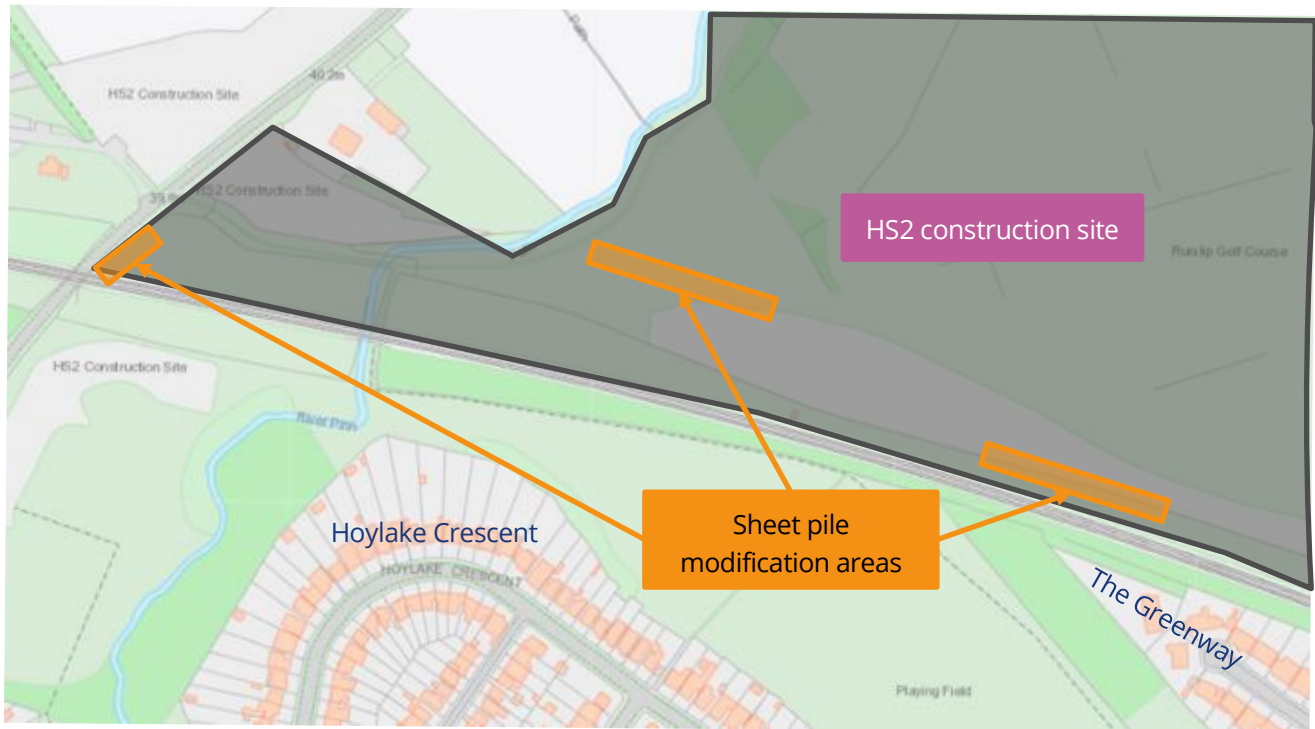
