Notice of Visual survey on the Hanger Lane Gyratory

High Speed Two (HS2) is the new high speed railway for Britain.

What are we doing

We will be carrying out a post visual condition survey on the Hanger Lane Gyratory and bridges following the completion of HS2 associated works from 18 November to 21 November 2025, overnight from 00:00 to 05:00am.

The surveys will be **non-intrusive** and will involve operatives on foot taking photos of the road and structures.

How this may affect you

We will need to temporarily close lanes on Hanger Lane and Western Avenue during each phase of works.

The locations of these works are shown on the maps on the following page.

We will have traffic cones and signage in the area to separate our operatives from traffic and allow them to carry out the surveys safely.

You may need to allow some additional time for Journeys.

We apologise for any inconvenience these works may cause.


