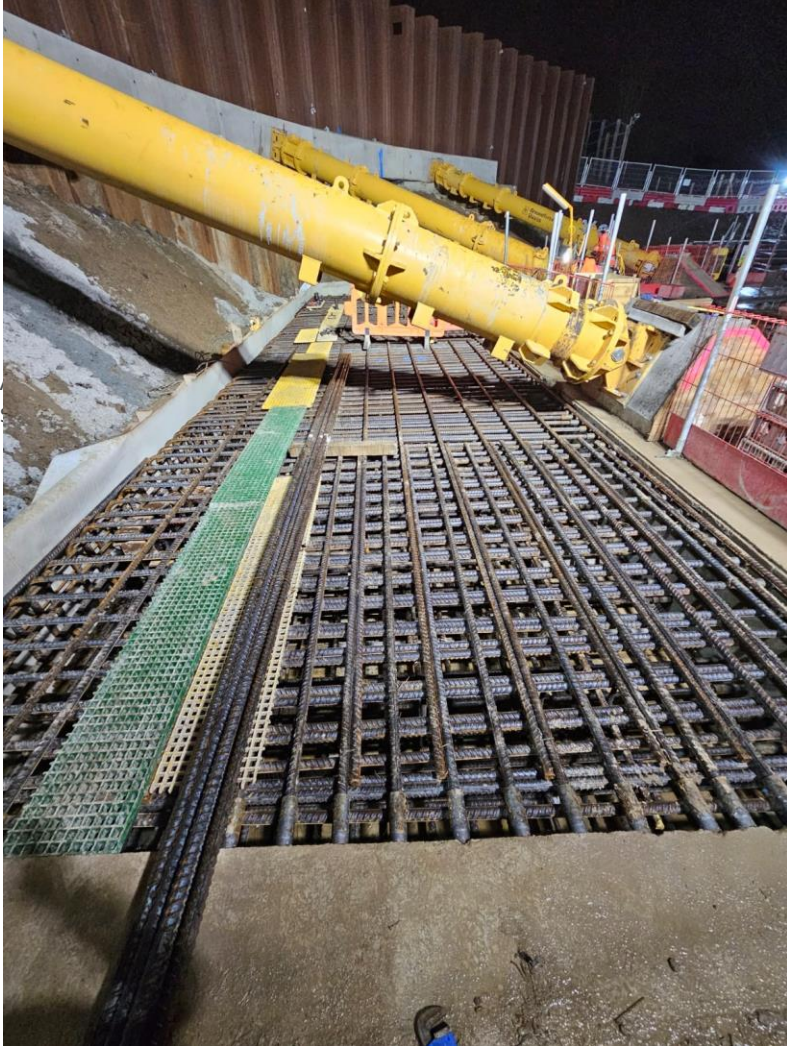
Last quarterly meeting: 15 September 2025

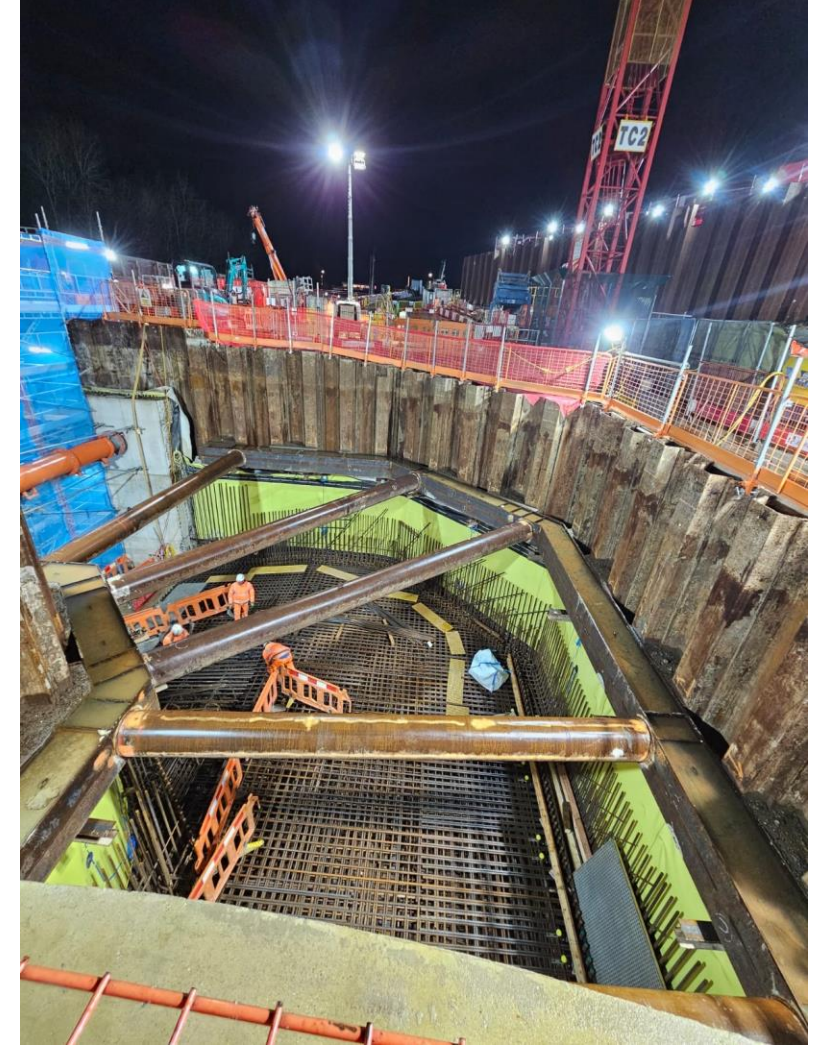

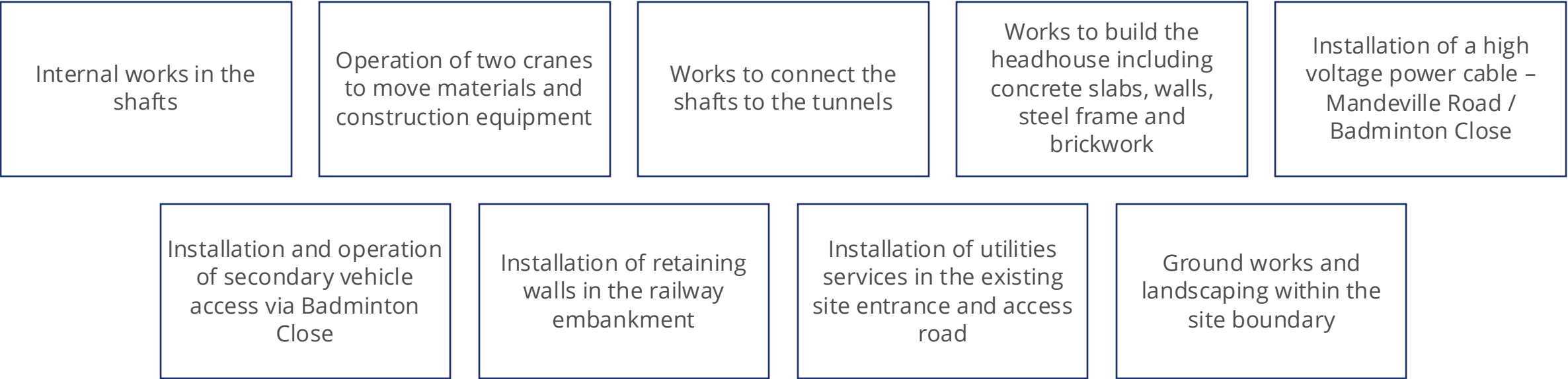

Summary of works planned from winter 2025/6 to winter 2026/7*

Tunnel connection works

24/7 works below ground to connect the tunnel and main shaft from 8 December to 23 December 2025 (Christmas shutdown 24 December to 4 January) and 5 to 21 January 2026

We're connecting the tunnel to the main shaft necessitating works to take place 24 hours a day for safety and engineering reasons.

Pre-cast tunnel lining segments are being removed working from inside the tunnel about 25 metres below ground.

To reduce night-time noise, concrete cutting (noisier works) are limited to 8am to 10pm (weekdays) and 8am - 6pm (weekend).

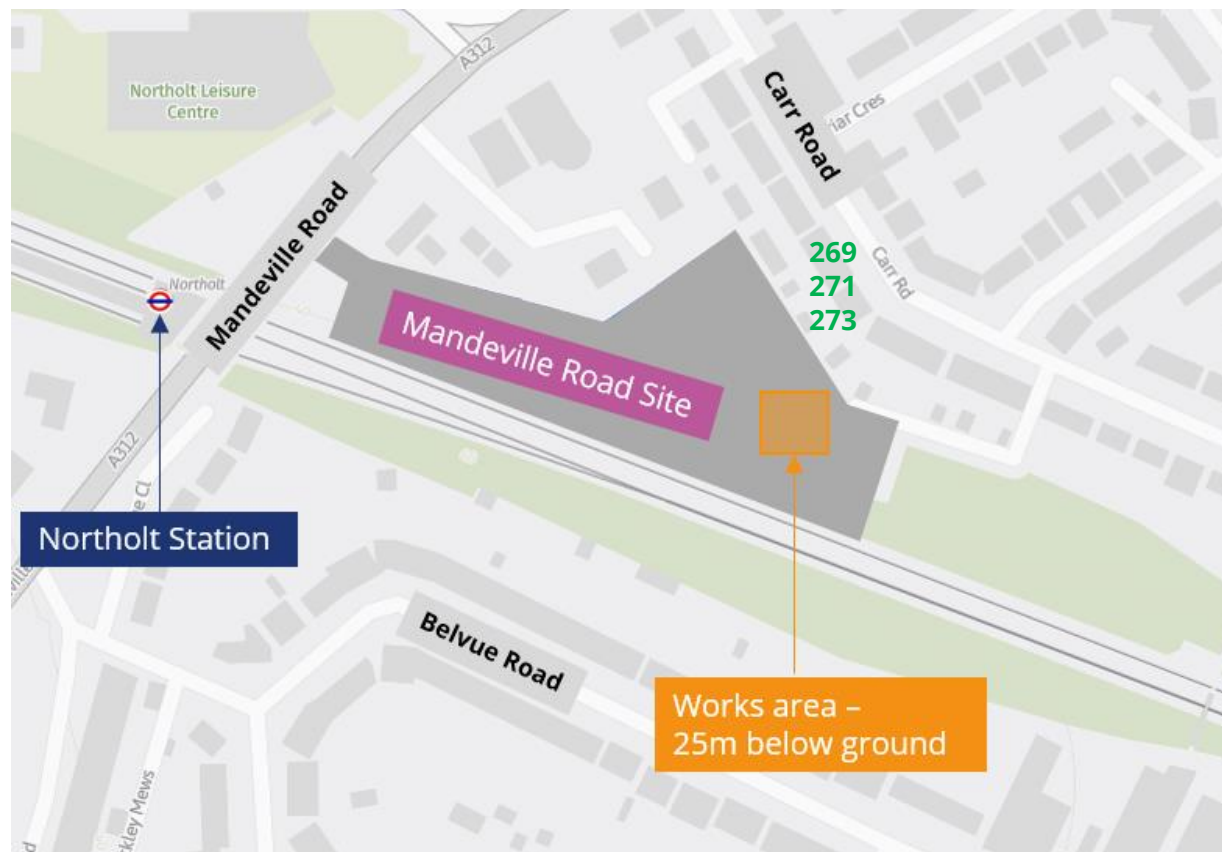
Ground borne noise may be heard depending on ground conditions and a building's structure.

The engagement team has been in contact with nearby residents to keep them updated on the works.

We're also building an adit (horizontal passage) below ground to connect the other tunnel and satellite shaft. The date for these works is yet to be confirmed. We'll write to you as soon as possible with more information.

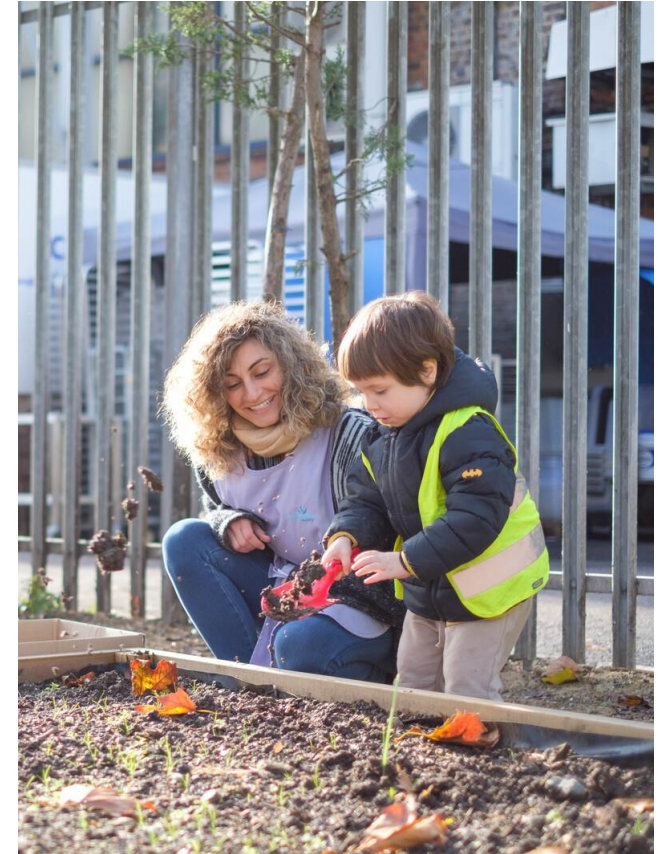
Community and Business Funds

HS2 is offering two funds that are available to local communities and businesses between the West Midlands and London, to help with the disruption caused by our construction work. These are the Community and Environment Fund (**CEF**) and the Business and Local Economy Fund (**BLEF**).

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
