Location

A38 southbound exit slip: Full closure of the exit slip road

A38 northbound: Cappers Lane to Hilliard's Cross

A38 southbound: Hilliard's Cross to Swinfen Interchange

Duration

A38 southbound exit slip: Five overnight closures **9pm to 6am Sunday 23 August to Thursday 27 August 2026** (inclusive)

A38 northbound: One overnight closure **9pm to 6am Monday 1 September 2026**

A38 southbound: One overnight closure **9pm to 6am Tuesday 2 September 2026**

We will be undertaking work on the off slip permanent barrier, installing signage and pavement investigation works. **These works are subject to consent.**

Where we will be working

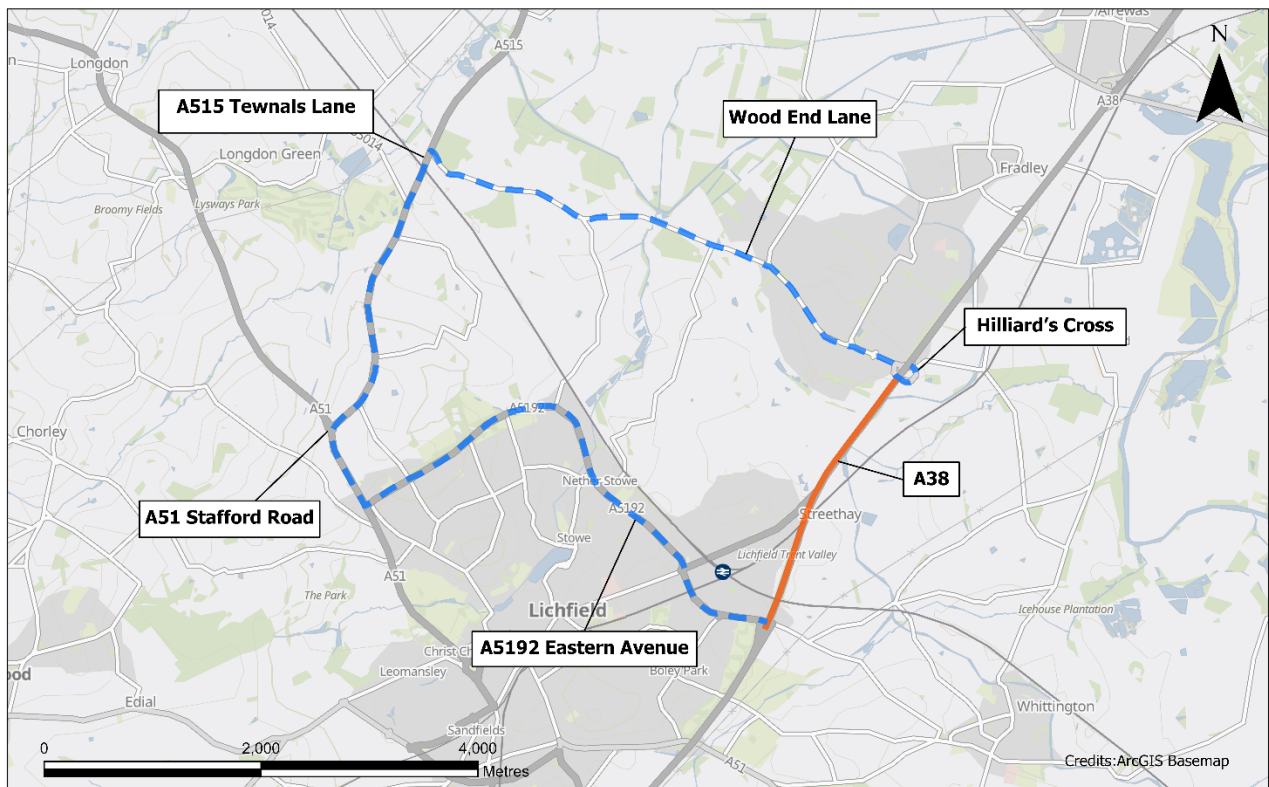
We will be working on the A38 in Lichfield between Swinfen Interchange and Hilliard's Cross.

Please see the maps and diversion routes below for the northbound and southbound carriageways and southbound exit slip

Please plan ahead and allow extra time for your journeys during the closure.

A38 northbound diversion route:

- Take the exit for Cappers Lane A5192 and turn left onto Cappers Lane
- Continue straight ahead at the next roundabout to Trent Valley roundabout
- Take the 3rd exit onto Eastern Avenue and continue ahead
- At the traffic lights, turn left on to A51 Stafford Road
- At the roundabout, take the 2nd exit onto A515 Tewnals Lane
- Turn right onto Wood End Lane and continue straight to rejoin the A38 northbound carriageway

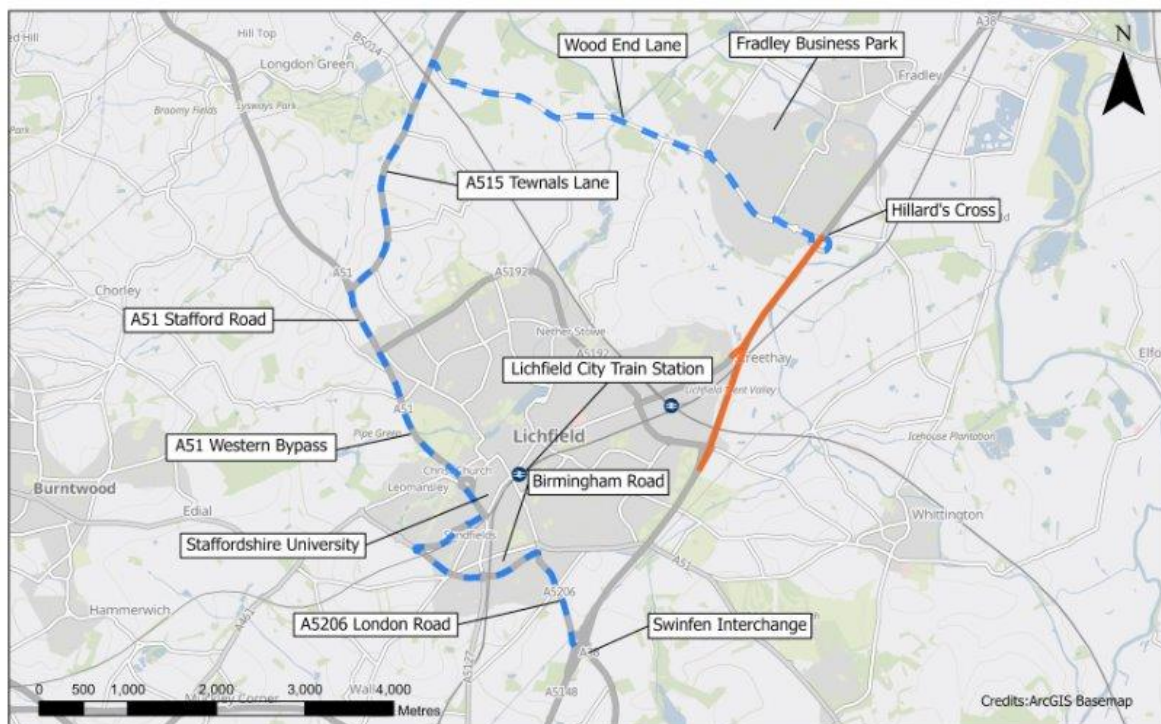

A38 southbound diversion route:

- Leave the A38 at Hilliard's Cross and turn left onto Wood End Lane.
- Continue straight ahead, then turn left onto Tewnals Lane to join the A515.
- At the roundabout, take the 1st exit towards the A51 Lichfield Western Bypass/Stafford Road.
- Continue straight over the roundabout onto The Friary.
- At the next roundabout, take the 3rd exit onto Sainte Foy Avenue.
- Proceed straight over the next two roundabouts then take the 1st exit onto the A461 Lichfield Southern Bypass.
- Continue to the traffic lights and turn right onto the A5206 London Road.
- Follow the A5206 back to Swinfen Interchange and rejoin the A38.

- Southbound traffic will continue on the A38 to Swinfen Interchange
- Take the 4th exit on the roundabout to join the A38 northbound
- Take the exit for Cappers Lane A5192 and turn left onto Cappers Lane
- Continue straight ahead at the next roundabout to Trent Valley roundabout where the diversion ends
