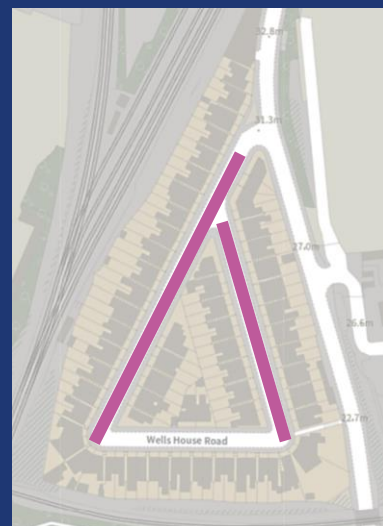


# Old Oak Common overnight concrete works

## Location

Old Oak Common station site, conventional station platforms

## Duration

**23 August 2026 – 31 July 2027**

We will be working overnight from Sunday to Friday, between 10pm to 6am. A schedule of upcoming nighttime works can be found overleaf.

## What we are doing

We are continuing the concrete works for the conventional station platforms, with works along the live railway.

## What to expect

We have to carry out these works overnight, when trains are not running. We will complete our activity as quickly as possible to reduce disruption. We will use equipment and methods which help to reduce noise. We will engage directly with residents impacted by these works. The works are described in more detail overleaf.

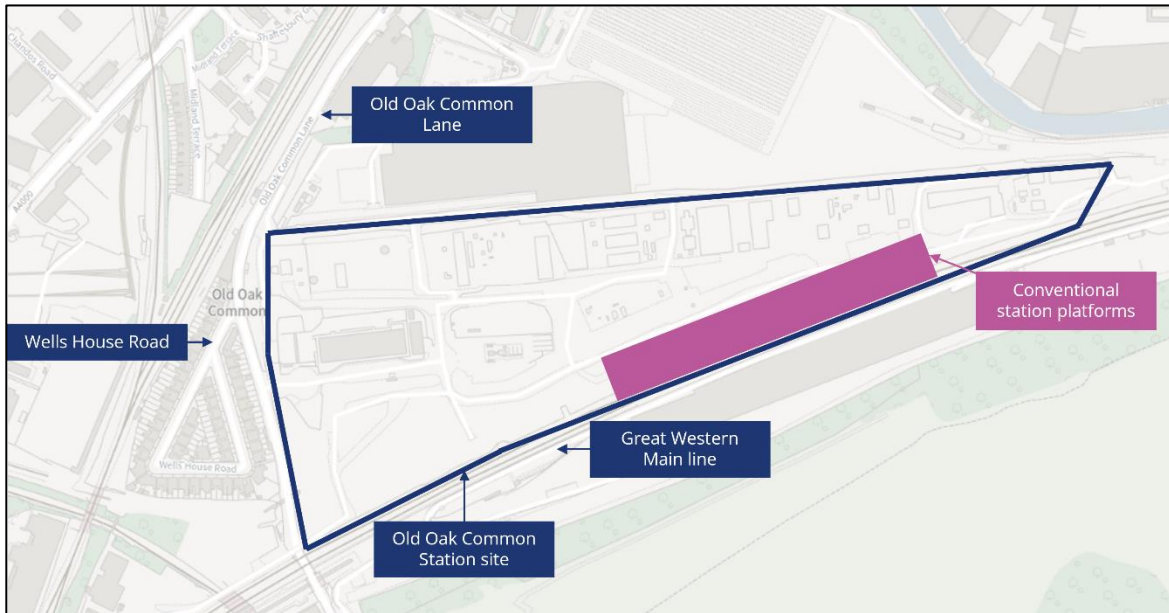

## Where we will be working

Works will be running alongside the Great Western Main Line on the conventional station platforms.



## Concrete platform works

We are continuing concrete works in the conventional station to deliver platforms and additional elements that will make up the future Elizabeth line and Great Western Main Line station. The works will involve concrete pours and installing prefabricated concrete planks. Due to the platforms running adjacent to the railway, to safely deliver the works, the teams will work overnight when trains are not running.

Other platform works were notified: **Old Oak Common: conventional station extended hours** (ref: HS2-OOC-SCP-26-2344).

## Working times

- Sunday 23 – Friday 28 August, except Wednesday 26 August
- Sunday 6 – Friday 11 September, except Monday 6 September and Thursday 7 September
- Tuesday 22 – Thursday 24 September
- All working hours within 10pm – 6am

Updates to this notification will be sent out once further dates are confirmed.

## Mitigations

We will minimise disruption by pointing lights away from residences and by using noise insulating blankets where appropriate. We will brief staff on entering and leaving site quietly.
